- the Draw site workforce housing project with updated drawings, some additional details on parking;
- the purchase of the residential land parcel next to Town Center;
- the rodeo construction - ready for June 19th 1st rodeo and community celebration will be June 26th;
- the summer line up of events is out;
- the Highline Road project scheduled to be done June 20th and the Lower Kearns Construction project is nearing completion - done early July.
- More updates on Owl & Brush roundabout are coming in - slow progression;
- Village shuttle - new App to help navigate the shuttle system;
- SkiCo Master Plan approval and clarification on how SkiCo will assist with Skittles.

Charlie Hess had emailed the members regarding public vs private roads and if Town should bring Gambel Way in as a public roadway. As Hess was not present, maybe table to future meeting. John Orton asked about what issues we should or not weigh in on.
