4. Administrative Updates & Discussion Items

4.a Winter Apres Event Debrief

Greg LeBlanc gave a quick summary of the event, attendees numbered 18, quite a bit less than planned. Weather was a contributing factor. Good presentation from Aspen Skiing Company. John Orton and Charlie Hess added comments. Suggestions for future events included: increased effort to publicize the event; ask HOAs to publicize to their list; change location to possibly the Gazebo, Chapel or Town Hall in Summer and Viewline Mountain Room in Winter; and need to decrease expenses. Talk about Summer meeting at the May PTRAB. General consensus for Mid-August (2nd and 3rd week).

4.b Areas of Focus for PTRAB in 2023

Chair Mayer opened topic to members to make suggestions for PTRAB focus going forward.

Roy Camberg - Educating people on public transportation options in the Village.

Charlie Hess - Organize a good summer meeting follow that up with a good fall newsletter with some of the information others are suggesting.

Norbert Hansch - Informing people on SMV Parking, specifically Recreational Center parking during ski season.

Mike Mayer- Focus on connectivity with newsletter; informing on hot topics.

Suggested discussing with not only PTRAB members but outreach to part-time residents as a larger group and then report to TC as needed. Give weight to part-time residents. Disseminate info outward. Suggestion: Make more effort to collect emails of part-time residents and develop a more robust database. Suggestion: Outreach to HOAs to send/invite a couple representatives from their HOA join a forum/discussion meeting to capture that broader group's opinions on specific topics. John Orton - Wanting to tap into expertise among the part-time residents. Proposing better engagement on a project-based level. Database/library that could assist TOSV on specific projects. LeBlanc clarified that TOSV has an established process for enlisting "professional" services but that if the focus is engagement, then this possibly could be incorporated.

Mike Brizel - Like Mike's idea of inviting a forum of +/- 2 reps from each HOA to a meeting to discuss general topics/concerns they have to bring to town and council.

Charlie Hess - Suggested a rotating PTRAB member attending TC meetings and reporting back to PTRAB and then communicating out to part-time residents through newsletter. Megan will add PTRAB to TC agenda email to keep members up to date on topics in front of Town Council.

4.c Summer Part-time Residents Communications

Leblanc suggested some form of Newsletter go to distribution list in late May for some pertinent information regarding construction, SMV transportation, Summer Events Schedule, Summer Meeting date. Members agreed.

Discussion on Summer Meeting dates - If Viewline or Collective - Thursday 4-5:30pm. If Gazebo - other day OK. Mid-August.

4.d Town Updates

Leblanc gave several updates on Town News:

Culvert project - May 4th, Town hall, Open house regarding construction.

Summer Events list will be finalized soon! Greg will send to PTRAB once finalized.

Wildlife closures in place in many places until June.

Short Term Rental - portal is live, push to get info out and get peeps in compliance.

Base Village - Second Viceroy tower & Aura will be under construction over summer, and maybe building 10 A & B will be started as well.

Ski Co and Coney Ski lift update.

Krabloonik - Still in legal process. No resolution as of today.
