BACKGROUND:

Section 8.3 of the Home Rule Charter states that members of all boards and commissions shall be appointed by the Town Council. The vacancies have been publicly posted, advertised in the Aspen Times and posted on social media from October 3rd to November 3rd.

We have received 35 applications, 19 new and 16 incumbents. Below is a breakdown of each Board including the number of vacant seats and number of total applications. Attached are all the applications received.

Non-incumbent, new, non-seated, and contested candidates received the **SparkHire** invitation on Tuesday November 18th. See attached list of all who received the SparkHire email and those that **responded** in **red** by the Tuesday November 24th deadline. A few applicants had technical difficulties and sent a written response. Link for the videos was sent Tuesday November 24th to all Council Members. Council discussed on December 1st and decided that no in-person interviews were required/requested. Today's work session is to discuss appointments to each Board. Staff will prepare a resolution for Council's consideration for the December 15th meeting.

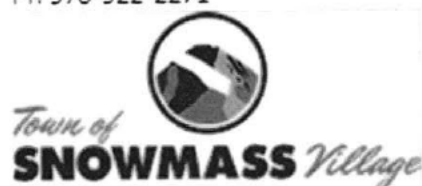
