Motion to approve GID Resolution No. 01, Series of 2025 made by Director Gustafson, seconded by Director DeAngelo. All in favor.

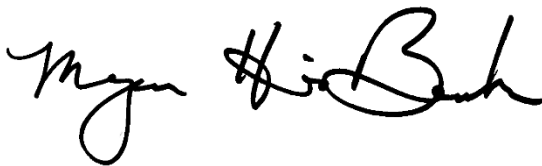
5. Adjournment
