18 A. PUBLIC HEARING - STAFF REPORT AND RESOLUTION NO. 01, SERIES OF 2021 A
19 RESOLUTION OF THE LOCAL MARIJUANA LICENSING AUTHORITY (LMLA) OF
20 THE TOWN OF SNOWMASS VILLAGE APPROVING, WITH CONDITIONS, A NEW
21 RETAIL MARIJUANA LICENSE FOR KATHERHOLZIG L.L.C. DOING BUSINESS AS
22 THE SNOWMASS DISPENSARY.

24 Chair of the LMLA Shenk opened the Public Hearing at this time. John Dresser, Town Attorney
25 is speaking on behalf of staff for a new Retail Marijuana License within the Town of Snowmass
26 Village. The new business is called Katherholzig LLC dba The Snowmass Dispensary located
27 16 Kearns Road Suite 202, Snowmass Village, CO 81615. All posting and publishing
28 requirement have been met for this application and today's hearing. Dresser continued by
29 explaining that normally the LMLA would be approving the local license at this hearing, but staff
30 and the applicant are asking the LMLA to approve LMLA Resolution No. 01, Series of 2021
31 which allows staff to approve the Retail Liquor License at a later date after conditions have been
32 met. The State has already approved this license and will issue the license on November 22,
33 2021. Staff reviewed this application and feels that it is complete enough for this Hearing. At
34 this time Andrew Light spoke and first wished Rhonda Coxon, Town Clerk a Happy Birthday and
35 thanked her for her support and work on the current application. He continued thanking the rest
36 of the Town staff that has worked with him through the application process and the support of
37 the community and of Rene Grossman who owns the other Retail Marijuana store in Snowmass
38 Village. There was a discussion regarding the name "Dispensary" which is normally related to
39 medical marijuana and hopefully this will not be confusing to the customer.

41 Chair Shenk took public comment at this time and some comments from the LMLA.

43 Tom Goode made the motion to approve LMLA Resolution No. 01, Series of 2021 - approving
44 with conditions the Retail Marijuana for The Snowmass Dispensary. Bill Madsen seconded the
45 motion. The motion was approved by a vote of 5 in favor to 0 opposed.
