Minutes

1. Roll Call

He pointed out that the 2026 Contract with TOSV is finalized and there is now funding to launch a benchmark program similar to those in Aspen & Basalt. CORE is working on a possible contract with Seasons Four to add a new roof and improved insulation. Discussions are also ongoing about possible projects with the Enclave, Willows, Snowmass Club and Fairway 3. The Villas North project is beginning any day to replace windows and improve insulation.

5.B. Pesticides Discussion

Discussion with Eric Brendlinger and Gwen Garcelon on Carbondale's successes and challenges establishing a Natural Land Management Plan rather than enforceable code requirements for noxious weed mitigation. Eric addressed the evolution of the plan's implementation in terms of the parks' individual management plans, staffing modifications, and the economic impacts of not using chemicals since 2019. Gwen spoke more to the evolution of the task force's work over more than five years of building relationships, consulting with field experts and exploring different weed mitigation techniques to write a plan and get it adopted.
